BY repealing and reenacting, with amendments, Article - Criminal Law Section 11–303 Annotated Code of Maryland (2002 Volume and 2008 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - Criminal Law** 11–303. (a) (1) A person may not knowingly: (i) take or cause another to be taken to any place for prostitution; EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW. 16 17 18 19	(c) (1) (i) Except as provided in paragraph (2) of this subsection, a person who violates subsection (a) of this section is guilty of the misdemeanor of human trafficking and on conviction is subject to imprisonment not exceeding 10 years or a fine not exceeding \$5,000 or both.
20 21	(ii) A person who violates subsection (a) of this section is subject to \S 5–106(b) of the Courts Article.
22 23 24	(2) A person who violates subsection (b) of this section is guilty of the felony of human trafficking and on conviction is subject to imprisonment not exceeding 25 years or a fine not exceeding \$15,000 or both.
