Procurement - Service Disabled Veteran Business Enterprise Participation

FOR the purpose of establishing a certain participation goal for certain certified service disabled veteran business enterprises for certain procurement contracts; requiring a certain awarding unit to consider certain efforts by and award certain contracts to certain bidders or offerors that meet or make a good-faith effort to meet certain participation goals; establishing certain criteria by which a contractor is considered to have made a good-faith effort to meet certain participation goals; requiring the Maryland Department of Veterans Affairs and the Department of Business and Economic Development jointly to adopt certain regulations; requiring the Department of Veterans Affairs and the Department of Business and Economic Development to designate an advocate to coordinate and oversee certain activities relating to service disabled veteran business enterprises; requiring an awarding unit to adopt certain regulations to meet the requirements of this Act; requiring an awarding unit to designate a service disabled veteran business enterprise advocate to assist the awarding unit in meeting goals related to service disabled veteran business enterprise participation; requiring certain awarding units to make certain reports on or before a certain date; requiring the Department of Veterans Affairs and the Department of Business and Economic Development to make certain reports on or before certain dates; requiring the Department of Business and Economic Development to adopt certain regulations regarding the decertification of certain entities and to oversee and coordinate certain outreach programs and activities; requiring the Department of Business and Economic Development to use certain resources to implement a certain program; establishing certain prohibited acts and certain penalties for certain violations; defining certain terms; and generally relating to procurement participation by service disabled veteran business enterprises.
