1 AN ACT concerning

### 2 **Carroll County – Board of Education – Election of Board Officers**

3 FOR the purpose of altering the title of the board officer of the Carroll County Board of  
4 Education from chairman to president; altering the date by which the ~~Carroll~~  
5 ~~County Board of Education~~ is required to elect a ~~president and vice president~~  
6 certain board officer from among its members; providing for the election of a  
7 vice president of the County Board from among its members; and generally  
8 relating to the Carroll County Board of Education.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

### 21 **Article – Education**

2 (d) (1) Each member serves for a term of 4 years beginning the first  
3 Monday in December immediately following the member's election and until a  
4 successor is elected and qualifies. The terms of the members are staggered as required  
5 for the elections to the county board in subsection (c)(1) of this section.

6 3-402.

7 At its first meeting [at the beginning of each year,] **ON OR AFTER THE FIRST**  
8 **MONDAY IN DECEMBER**, the county board shall elect a [chairman] **PRESIDENT AND**  
9 **VICE PRESIDENT** from among its members.

10 3-403.

11 (a) The [chairman] **PRESIDENT** of the county board is entitled to receive  
12 \$7,500 annually as compensation and the other members are entitled to receive \$6,500  
13 each annually as compensation.

14 (b) The compensation of the [chairman] **PRESIDENT** and the members  
15 described in subsection (a) of this section shall be paid in four equal quarterly  
16 installments.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
18 October 1, 2009.
