12 13	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

16 17 18	(i) (1) Subject to paragraphs (2) and (3) of this subsection, "socially and economically disadvantaged individual" means a citizen or lawfully admitted permanent resident of the United States who is:
19	(i) in any of the following minority groups:

22 23	2. American Indian/Native American – an individual having origins in any of the original peoples of North America and who is a

- 3 other form of recognition. This includes an individual who claims to be an American
- 4 Indian/Native American and who is regarded as such by the American Indian/Native

- 6 an individual of Eskimo or Aleutian origin;
- 7 3. Asian an individual having origins in the Far East,
- 8 Southeast Asia, or the Indian subcontinent, and who is regarded as such by the
