A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Handgun Permits – Federal Flight Deck Officers**

3 FOR the purpose of requiring the Secretary of State Police to issue a permit to carry,
4 wear, or transport a handgun within a reasonable time to an applicant who can
5 provide documentation that the applicant has successfully completed the
6 Federal Flight Deck Officer Program of the Transportation Security
7 Administration of the United States Department of Homeland Security and has
8 been authorized to use a firearm to defend against an act of criminal violence or
9 air piracy committed by a person who is attempting to gain control of an
10 aircraft; and generally relating to permits to carry, wear, or transport a
11 handgun.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article – Public Safety**

20 5–306.

21 (a) Subject to subsection (b) **AND (C)** of this section, the Secretary shall issue
22 a permit within a reasonable time to a person who the Secretary finds:

23 (1) is an adult;

1 (2) (i) has not been convicted of a felony or of a misdemeanor for
2 which a sentence of imprisonment for more than 1 year has been imposed; or

3 (ii) if convicted of a crime described in item (i) of this item, has
4 been pardoned or has been granted relief under 18 U.S.C. § 925(c);

5 (3) has not been convicted of a crime involving the possession, use, or
6 distribution of a controlled dangerous substance;

7 (4) is not presently an alcoholic, addict, or habitual user of a controlled
8 dangerous substance unless the habitual use of the controlled dangerous substance is
9 under legitimate medical direction; and

10 (5) based on an investigation:

11 (i) has not exhibited a propensity for violence or instability that
12 may reasonably render the person's possession of a handgun a danger to the person or
13 to another; and

14 (ii) has good and substantial reason to wear, carry, or transport
15 a handgun, such as a finding that the permit is necessary as a reasonable precaution
16 against apprehended danger.

17 (b) An applicant under the age of 30 years is qualified only if the Secretary
18 finds that the applicant has not been:

19 (1) committed to a detention, training, or correctional institution for
20 juveniles for longer than 1 year after an adjudication of delinquency by a juvenile
21 court; or

22 (2) adjudicated delinquent by a juvenile court for:

23 (i) an act that would be a crime of violence if committed by an
24 adult;

25 (ii) an act that would be a felony in this State if committed by
26 an adult; or

27 (iii) an act that would be a misdemeanor in this State that
28 carries a statutory penalty of more than 2 years if committed by an adult.

29 (c) **THE SECRETARY SHALL ISSUE A PERMIT WITHIN A REASONABLE**
30 **TIME TO AN APPLICANT WHO CAN PROVIDE DOCUMENTATION THAT THE**
31 **APPLICANT HAS SUCCESSFULLY COMPLETED THE FEDERAL FLIGHT DECK**
32 **OFFICER PROGRAM OF THE TRANSPORTATION SECURITY ADMINISTRATION OF**
33 **THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY AND HAS BEEN**

1 AUTHORIZED TO USE A FIREARM TO DEFEND AGAINST AN ACT OF CRIMINAL
2 VIOLENCE OR AIR PIRACY COMMITTED BY A PERSON WHO IS ATTEMPTING TO
3 GAIN CONTROL OF AN AIRCRAFT.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2009.
