#### 1 AN ACT concerning

# Programs for Children in Out-of-Home Placement - System for Outcomes Evaluation

- 4 FOR the purpose of expanding the programs to which certain provisions relating to a 5 certain system for outcomes evaluation for certain programs for children in 6 out-of-home placement apply; exempting certain facilities and programs from 7 certain provisions relating to a certain system for outcomes evaluation; altering 8 certain definitions to include certain programs for purposes of certain provisions relating to a certain system for outcomes evaluation; providing for the effective 9 dates of this Act; and generally relating to children in out-of-home placement 10 11 and a certain system for outcomes evaluation.

1 The Department of Juvenile Services, the Department of Human Resources, the  $\mathbf{2}$ Department of Health and Mental Hygiene, and the Governor's Office for Children shall jointly adopt regulations requiring each member of a direct care staff to: 3 4 (1)be at least 21 years old; and 5 complete a training program that is approved by the agency that (2)licensed the residential child care program. 6 7 [8–1003.] **8–1004.** 8 On or before July 1, 2008, the Office and the cooperating departments (a)shall develop, coordinate, and implement a system for outcomes evaluation. 9 10 (b) The system for outcomes evaluation shall be used to: 11 (1)monitor the care, supervision, education, and treatment provided 12by State-operated and State-supported [residential child care programs] **PROGRAMS** 13**DESCRIBED IN § 8–1001(D)(2) OF THIS SUBTITLE** so that successful services can be expanded and services that do not produce positive results can be identified; 14 15(2)establish an evaluation system for program performance, including measures of safety, quality, and effectiveness; and 16 17(3)complete an assessment of the [State's residential child care 18 program] capacity OF THE PROGRAMS DESCRIBED IN § 8-1001(D)(2) OF THIS SUBTITLE IN THE STATE that identifies [residential child care] programs in each 19 community to serve the needs of a family that resides in the community. 20 21 $(\mathbf{c})$ The system for outcomes evaluation shall use standardized measures of 22function to evaluate the child's: 23protection from harm while in out-of-home placement; (1)24(2)stability of living environment; 25(3)family situation and efforts to treat and counsel the family unit; educational and vocational development; 26(4)job skills and employment readiness; 27(5)28(6) legal and appropriate use of drugs and alcohol; 29 progress in learning positive, nonaggressive behavioral habits; and (7)

30 (8) delinquency status.

1 (d) The system for outcomes evaluation shall ensure that collection and use 2 of data in the system maintains confidentiality of information on the children from the 3 cooperating departments.

4 (e) The system for outcomes evaluation shall ensure that a cooperating 5 department shall:

6 (1) facilitate the participation of [residential child care] programs 7 **DESCRIBED IN § 8–1001(D)(2) OF THIS SUBTITLE** operated by the cooperating 8 department or private agencies with which the cooperating department has a contract 9 for the placement of children in out-of-home care; and

10 (2) include in the cooperating department's contract with a private 11 [residential child care] program provisions requiring the program to collect and report 12 to the cooperating department:

(i) child–specific demographic information; and

(ii) data necessary to evaluate changes in functioning of thechild as provided in subsection (c) of this section.

16 (f) When reporting demographic information and data under subsection (e) 17 of this section, a cooperating department:

- (1) may not disclose personal identifiers; and

19 (2) shall ensure the confidentiality of the information about the 20 children under its responsibility.

(g) On or before October 1 of each year, the Office, in coordination with the cooperating departments, shall submit a report to the Governor and, in accordance with § 2–1246 of the State Government Article, to the General Assembly on the progress of implementing the system for outcomes evaluation.

11 SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in 12 Section 3 of this Act, this Act shall take effect July 1, 2009.
