A BILL ENTITLED

1 AN ACT concerning

Frederick County - Alcoholic Beverages - Wine Festival License

3 FOR the purpose of establishing a special wine festival (WF) license in Frederick 4 County; requiring that an applicant for a special WF license must be a holder of 5 a certain other license; specifying that a holder of a special WF license may 6 display and sell wine in a certain manner; requiring the Frederick County 7 Board of License Commissioners to assure that the primary focus of the festival 8 is the promotion of Maryland wine; requiring a holder of a special WF license to 9 display and sell certain wine; providing for a license fee; providing that this Act 10 does not prohibit the holder of a special WF license from holding another alcoholic beverages license; authorizing the Board to choose certain weekends 11 for festivals; requiring the Board to choose certain locations for the festivals; 12 requiring the Board to adopt certain regulations; defining certain terms; and 13 14 generally relating to wine in Frederick County.

3 Article 2B - Alcoholic Beverages

- 5 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE 6 MEANINGS INDICATED.
- 7 (2) "BOARD" MEANS THE FREDERICK COUNTY BOARD OF 8 LICENSE COMMISSIONERS.
- 9 (3) "FESTIVAL" MEANS THE FREDERICK COUNTY WINE 10 FESTIVAL.
- 11 (B) THIS SECTION APPLIES ONLY IN FREDERICK COUNTY.
- 12 (C) THE BOARD MAY ISSUE A SPECIAL WINE FESTIVAL (WF) LICENSE.
- 13 (D) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, TO
- 14 BE ELIGIBLE FOR A SPECIAL WF LICENSE, AN APPLICANT MUST BE A HOLDER
- 15 OF AN EXISTING STATE RETAIL ALCOHOLIC BEVERAGES LICENSE, A STATE
- 16 CLASS 3 WINERY LICENSE, OR A STATE CLASS 4 LIMITED WINERY LICENSE.
- 17 (E) A SPECIAL WF LICENSE ENTITLES THE HOLDER TO DISPLAY AND
- 18 SELL AT RETAIL WINE FOR CONSUMPTION ON OR OFF THE PREMISES ON THE
- 19 DAYS AND FOR THE HOURS DESIGNATED FOR A FESTIVAL IN THE COUNTY.
- 20 (F) (1) THE BOARD SHALL ASSURE THAT THE PRIMARY FOCUS OF 21 THE FESTIVAL IS THE PROMOTION OF MARYLAND WINE.
- 22 (2) A HOLDER OF A SPECIAL WF LICENSE SHALL DISPLAY AND SELL WINE THAT IS DISTRIBUTED IN THE STATE.
- 24 (G) THE SPECIAL WF LICENSE FEE IS \$20.
- 25 (H) This section does not prohibit the holder of a special WF 26 License from holding another alcoholic beverages license of a
- 27 DIFFERENT CLASS OR NATURE.
- 28 (I) THE BOARD MAY CHOOSE 2 WEEKENDS ANNUALLY FOR FESTIVALS.

- 1 (J) THE BOARD SHALL CHOOSE LOCATIONS IN THE COUNTY FOR THE 2 FESTIVALS THAT ARE NOT LICENSED UNDER THIS ARTICLE.
- 3 $\,$ (K) The Board shall adopt regulations to carry out this 4 $\,$ section.
- 5 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 6 July 1, 2009.
