17 (a) Except as provided in subsection (b) of this section and §§ 31–111.1, 18 31–111.3, [and] 31–111.4, AND 31–111.5 of this subtitle, if an employee of a 19 participating governmental unit joins the Employees' Pension System within 1 year 20 after the effective date, the employee is entitled to service credit for employment with 21 the participating governmental unit before the effective date.

(b) If an employee of the Baltimore Metropolitan Council elects to become a member of the Employees' Retirement System or the Employees' Pension System, the employee may not receive credit for service from July 1, 1992, to the effective date unless the employee pays to the Board of Trustees the amount of the member contributions the employee would have made during that period, plus regular interest.

(A) AN INDIVIDUAL WHO IS AN EMPLOYEE OF THE TOWN OF
SYKESVILLE ON THE EFFECTIVE DATE SHALL RECEIVE ELIGIBILITY SERVICE
AND CREDITABLE SERVICE IN THE EMPLOYEES' PENSION SYSTEM EQUAL TO
75% OF THE INDIVIDUAL'S PERIOD OF EMPLOYMENT WITH THE TOWN OF
SYKESVILLE BEFORE THE EFFECTIVE DATE AS CERTIFIED BY THE TOWN OF
SYKESVILLE AS OF THE EFFECTIVE DATE.

1 (B) IF AN EMPLOYEE OR FORMER EMPLOYEE OF THE TOWN OF 2 SYKESVILLE BECOMES A MEMBER OF THE EMPLOYEES' PENSION SYSTEM AT 3 ANY TIME AFTER THE EFFECTIVE DATE, THE EMPLOYEE MAY NOT RECEIVE 4 SERVICE CREDIT FOR EMPLOYMENT WITH THE TOWN OF SYKESVILLE BEFORE 5 THE EFFECTIVE DATE.

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 July 1, 2009.
