14 15	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

18	(a) (1) In this section the following words have the meanings indicated.
19 20 21	(2) "Local official" means an individual serving in a publicly elected office of a local government unit, as defined in § 10–101 of the State Government Article.
22 23	(3) (i) "State official" has the meaning stated in § 15–102 of the State Government Article.



$\frac{1}{2}$	(ii) "State official" includes the Governor, Governor–elect.
3	(4) "Threat" includes:
4	(i) an oral threat; or
5 6 7	(ii) a threat in any written form, whether or not the writing is signed, or if the writing is signed, whether or not it is signed with a fictitious name or any other mark.
8 9 10	(b) A person may not knowingly and willfully make a threat to take the life of, kidnap, or cause physical injury to a State official [or], A local official, A DEPUTY STATE'S ATTORNEY, OR AN ASSISTANT STATE'S ATTORNEY.
11 12 13	(c) A person may not knowingly send, deliver, part with, or make for the purpose of sending or delivering a threat prohibited under subsection (b) of this section.
14 15 16	(d) A person who violates this section is guilty of a misdemeanor and on conviction is subject to imprisonment not exceeding 3 years or a fine not exceeding \$2,500 or both.
17 18	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2009.
