AN ACT concerning 1

3	FOR the purpose of including the discipline and discharge of an employee for just

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 20
- MARYLAND, That the Laws of Maryland read as follows: 21

- 1 In this subtitle the following words have the meanings indicated. (a) 2 "Confidential employee" includes an individual whose employment (b) responsibilities require knowledge of the public school employer's posture in the 3 4 collective negotiation process, as determined by the public school employer in negotiations with an employee organization that requests negotiation on this issue. 5 6 "Employee organization" means an organization that: (c) 7 **(1)** Includes noncertificated employees of a public school employer; and 8 Has as one of its main purposes the representation of the 9 employees in their relations with that public school employer. 10 "Management personnel" includes an individual who is engaged mainly 11 in executive and managerial functions, as determined by the public school employer in 12 negotiation with an employee organization that requests negotiation on this issue. 13 "Noncertificated employee", in Montgomery County, means only a 14 full-time employee. "Public school employee" means a noncertificated individual who is 15 **(1)** 16 employed for at least 9 months a year on a full-time basis by a public school employer. 17 "Public school employee" includes a noncertificated employee in Baltimore City notwithstanding that the noncertificated employee does not work for at 18 least 9 months a year on a full-time basis. 19 20 "Public school employee" does not include: (3)21 (i) Management personnel; 22A confidential employee; or (ii) 23(iii) Any individual designated by the public school employer to 24 act in a negotiating capacity as provided in § 6–510(b) of this subtitle. "Public school employer" means the county board in each county. 25 (g) **(1)** 26 "Public school employer" includes the Baltimore City Board of (2)School Commissioners. 27
  - (h) "Supervisory employee" includes any individual who responsibly directs the work of other employees, as determined by the public school employer in negotiation with an employee organization that requests negotiation on this issue.

- In this section, "negotiate" includes the duty to: 1 (a) (1) 2 (i) Confer in good faith, at all reasonable times; and 3 (ii) Reduce to writing the matters agreed on as a result of the 4 negotiations. 5 The agreements may provide for binding arbitration of the (2)6 grievances arising under the agreement that the parties have agreed to be subject to 7 arbitration. 8 (b) On request, a public school employer or at least two of its 9 designated representatives shall meet and negotiate with at least two representatives of the employee organization that is designated as the exclusive negotiating agent for 10 11 the public school employees in a unit of the county on all matters that relate to 12 salaries, wages, hours, and other working conditions, INCLUDING THE DISCIPLINE AND DISCHARGE OF AN EMPLOYEE FOR JUST CAUSE, AND EMPLOYEE 13 14 TRANSFERS AND ASSIGNMENTS. 15 Except as provided in paragraph (3) of this subsection, a public school employer or at least two of its designated representatives may negotiate with at 16 17 least two representatives of the employee organization that is designated as the exclusive negotiating agent for the public school employees in a unit of the county on 18 19 other matters[, including due process for discipline and discharge,] that are mutually 20 agreed to by the employer and the employee organization. 21 A public school employer may not negotiate the school calendar, 22the maximum number of students assigned to a class, or any matter that is precluded 23 by applicable statutory law. 24A matter that is not subject to negotiation under paragraph (2) of (4) 25 this subsection because it has not been mutually agreed to by the employer and the employee organization may not be raised in any action taken to resolve an impasse 26 under subsection (d) of this section. 27 28 The designation of representatives by the employer under this section does not prevent an employee organization from appearing before or making proposals 29 30 to the public school employer at a public meeting or hearing. 31 (d) If, on the request of either party, the State Superintendent **(1)** 32 determines from the facts that an impasse is reached in negotiations between a public 33 school employer and an employee organization that is designated as an exclusive negotiating agent, the assistance and advice of the State Board may be requested, 34 35 with the consent of both parties.
  - (2) If consent is not given and at the request of either party, a panel shall be named to aid in resolving the differences.
