- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 2122MARYLAND, That the Laws of Maryland read as follows:

21 22 23 24	(c) (1) Except as provided in subsection $(b)(2)(iii)$ of this section, at least 45 days before the filing of an action to foreclose a mortgage or deed of trust on residential property, the secured party shall send a written notice of intent to foreclose to the mortgagor or grantor and the record owner.
25	(2) The notice of intent to foreclose shall be sent:
