3 (D) THE BOARD MAY ISSUE THE LICENSE FOR USE IN A CORPORATE 4 HEADQUARTERS SUPPORT FACILITY THAT SERVES ONLY THE WORKFORCE 5 TRAINING AND EDUCATION NEEDS OF EMPLOYEES, CUSTOMERS, AND VISITORS 6 TO THE CORPORATE HEADQUARTERS OF A CORPORATION THAT EMPLOYS AT 7 LEAST 500 EMPLOYEES IN THE COUNTY.

- 8 (E) SALES OF ALCOHOLIC BEVERAGES UNDER THIS SECTION ARE ONLY 9 FOR ON-PREMISES CONSUMPTION.
- 10 (F) THE ANNUAL LICENSE FEE IS \$2,500.

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 12 June 1, 2009.
