BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 2122**Article – Natural Resources** 2310 - 410.

## HOUSE BILL 831

1 (o) (1) In Anne Arundel, Baltimore, Howard, [Montgomery,] and Prince 2 George's counties, a person may not use, set, place, or maintain any steel jaw leghold 3 trap on land. The steel jaw leghold trap may be used for the capture of fur-bearing 4 mammals in water only.

- (2) This subsection does not apply to:

6 (i) Traps set on farmland by the owner of the farmland, by the 7 owner's agent or tenant, owner's lessee, or by any member of the owner's or tenant's 8 immediate family who resides on the farmland; or

9 (ii) Traps set by an authorized agent of the [Maryland Forest,
10 Park and Wildlife Service] **DEPARTMENT** who exercises the [agent's] duties **OF THE**11 **AGENT** for wildlife control under guidelines established by the Department.

12 (0–1) (1) IN MONTGOMERY COUNTY, A PERSON MAY NOT USE, SET, 13 PLACE, OR MAINTAIN A STEEL JAW LEGHOLD OR BODY–GRIPPING TRAP.

14 (2) THIS SUBSECTION DOES NOT APPLY TO A TRAP SET BY AN
 15 AUTHORIZED AGENT OF THE DEPARTMENT WHO EXERCISES THE DUTIES OF THE
 16 AGENT FOR WILDLIFE CONTROL UNDER GUIDELINES ESTABLISHED BY THE
 17 DEPARTMENT.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect19 July 1, 2009.
