- 23 MARYLAND, That the Laws of Maryland read as follows:

- 3 (2) This section does not apply in Wicomico County.
- 4 (d) Except in Howard, Montgomery, and Prince George's counties, **AND**5 **EXCEPT AS PROVIDED IN SUBSECTION (G) OF THIS SECTION,** a new or used car
 6 dealer may not sell, barter, deliver, give away, show, or offer for sale a motor vehicle or
 7 certificate of title for a motor vehicle on Sunday.
- 8 (e) In Anne Arundel County, a dealer may sell, barter, deliver, give away, 9 show, or offer for sale on Sunday a new or used camping trailer, mobile home, or travel 10 trailer, as those terms are defined in Title 11 of the Transportation Article.
- 11 (f) A new or used car dealer who violates subsection (d) of this section is 2 guilty of a misdemeanor and, on conviction, is subject to a fine not exceeding \$10,000.
- 13 (G) IN WORCESTER COUNTY, A DEALER MAY SELL, BARTER, DELIVER, 14 GIVE AWAY, SHOW, OR OFFER FOR SALE A MOTORCYCLE, AS DEFINED IN § 11–136 OF THE TRANSPORTATION ARTICLE, OR CERTIFICATE OF TITLE FOR A MOTORCYCLE ON A SUNDAY.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 July 1, 2009.
