## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Worcester County – Motorcycle Dealers – Sunday Operations**

3 FOR the purpose of authorizing in Worcester County a motorcycle dealer to sell,  
4 barter, deliver, give away, show, or offer for sale a motorcycle or a certificate of  
5 title for a motorcycle on Sunday; providing for a certain effective date; and  
6 generally relating to motorcycle dealers in Worcester County.

9 Section 18–101(a), (e), and (f)

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article – Business Regulation**

4 18–101.

5 (a) (1) This section does not apply to the laws that relate to the sale of  
6 alcoholic beverages.

7 (2) This section does not apply in Wicomico County.

8 (d) Except in Howard, Montgomery, and Prince George’s counties, **AND**  
9 **EXCEPT AS PROVIDED IN SUBSECTION (G) OF THIS SECTION**, a new or used car  
10 dealer may not sell, barter, deliver, give away, show, or offer for sale a motor vehicle or  
11 certificate of title for a motor vehicle on Sunday.

12 (e) In Anne Arundel County, a dealer may sell, barter, deliver, give away,  
13 show, or offer for sale on Sunday a new or used camping trailer, mobile home, or travel  
14 trailer, as those terms are defined in Title 11 of the Transportation Article.

15 (f) A new or used car dealer who violates subsection (d) of this section is  
16 guilty of a misdemeanor and, on conviction, is subject to a fine not exceeding \$10,000.

17 **(G) IN WORCESTER COUNTY, A DEALER MAY SELL, BARTER, DELIVER,**  
18 **GIVE AWAY, SHOW, OR OFFER FOR SALE A MOTORCYCLE, AS DEFINED IN §**  
19 **11–136 OF THE TRANSPORTATION ARTICLE, OR CERTIFICATE OF TITLE FOR A**  
20 **MOTORCYCLE ON A SUNDAY.**

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
22 July 1, 2009.
