3 FOR the purpose of prohibiting a person from distributing certain tobacco-containing 4 and tobacco-related products to a minor in Cecil County; establishing a certain 5 civil infraction and certain civil penalty; authorizing a certain law enforcement 6 officer in Cecil County to issue certain civil citations in certain circumstances; 7 requiring certain persons issued a certain citation in Cecil County to file a 8 certain notice with a certain District Court in order to elect to stand trial for a 9 certain offense; and generally relating to the distribution of tobacco products to 10 minors in Cecil County.

 THIS SUBSECTION, A person who receives a citation under this title may elect to
 stand trial for the offense by filing with the county health officer a notice of intention
 to stand trial.

6 (2) IN CECIL COUNTY, A PERSON WHO RECEIVES A CITATION 7 UNDER THIS TITLE MAY ELECT TO STAND TRIAL FOR THE OFFENSE BY FILING A 8 NOTICE OF INTENTION TO STAND TRIAL WITH A COPY OF THE CITATION WITH 9 THE DISTRICT COURT HAVING VENUE AT LEAST 5 DAYS BEFORE THE DATE SET 10 FORTH IN THE CITATION FOR PAYMENT OF THE CIVIL PENALTY.

14 (c) After receiving a notice of intention to stand trial **FROM A PERSON** 15 **PROVIDING NOTICE UNDER SUBSECTION (A)(1) OF THIS SECTION**, the county 16 health officer shall forward the notice to the District Court having venue, with a copy 17 of the citation.

18 (d) After receiving the citation and notice, the District Court shall schedule
19 the case for trial and notify the defendant of the trial date.

20 (e) All penalties and forfeitures collected by the District Court for violations 21 of this title shall be remitted to the county in which the violation occurred.

(f) In a proceeding before the District Court, a violation shall be prosecuted
in the same manner and to the same extent as a municipal infraction under Article
23A, § 3(b)(7) through (15) of the Code.

(g) The county commissioners of the county in which the violation occurred
 may authorize the county attorney to prosecute a civil infraction under this title.

(h) If the District Court finds that a person has committed a civil infractionunder this title, the person shall be liable for the costs of the court proceedings.

(i) The finding by the District Court of a violation under this title is not a
criminal conviction and does not impose any of the civil disabilities ordinarily imposed
by a criminal conviction.
