# 2 Higher Education - Part-Time Grant Program - Eligibility

- degree-granting program at an eligible institution and taking at least [6] 3 but no
- more than 11 semester hours of courses each semester.

(b) Funds for the grant program for part-time students shall be as provided in the annual budget of the Commission by the Governor.
