1 2 3	(2) THE BOARD OF LICENSE COMMISSIONERS MAY ISSUE A SPECIAL 1-DAY CLASS C BEER, WINE AND LIQUOR LICENSE TO A NONPROFIT ORGANIZATION THAT:
4 5	(I) IS EXEMPT FROM TAXATION UNDER $\S501(\mathrm{C})(3)$ OF THE INTERNAL REVENUE CODE; AND
6 7	(II) HAS ITS PRINCIPAL PLACE OF BUSINESS IN THE 26TH LEGISLATIVE DISTRICT.
8 9	(3) THE SPECIAL LICENSE ENTITLES THE HOLDER TO SELL BEER, WINE, OR LIQUOR FOR CONSUMPTION ON OR OFF THE PREMISES.
10	(4) THE FEE FOR A SPECIAL LICENSE IS \$150 PER DAY.
11 12 13	(5) THE SPECIAL LICENSE MAY NOT BE ISSUED TO ANY ONE ORGANIZATION FOR MORE THAN 4 CONSECUTIVE DAYS OR FOR MORE THAN 8 DAYS IN A SINGLE CALENDAR YEAR.
14 15 16	(6) THE SPECIAL LICENSE SHALL BE SIGNED BY AT LEAST ONE OFFICER OF THE ORGANIZATION WHO IS A RESIDENT OF THE 26TH LEGISLATIVE DISTRICT AND A REGISTERED VOTER AND TAXPAYER OF THE COUNTY.

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
