## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Public Service Companies – Passenger-For-Hire Services – Limousines**

3 FOR the purpose of repealing a certain provision exempting a certain limousine  
4 services permit from a certain annual assessment; authorizing the use of the  
5 For-Hire Driving Services Enforcement Fund for certain enforcement activities  
6 relating to limousine services; altering the definition of “limousine” for purposes  
7 of certain vehicle laws; prohibiting an individual from operating for hire a  
8 limousine designed to carry no more than a certain number of passengers unless  
9 the individual holds a certain for-hire driver’s license and the limousine  
10 displays certain registration plates; prohibiting a person from permitting an  
11 individual to operate for hire a limousine designed to carry no more than a  
12 certain number of passengers unless the individual operating the limousine  
13 holds a certain for-hire driver’s license and the limousine displays certain  
14 registration plates; providing for a certain penalty for a violation of certain  
15 provisions of this Act; requiring that a certain number of points be assessed  
16 against an individual under a certain point system maintained by the Motor  
17 Vehicle Administration for a violation of ~~certain provisions~~ a certain provision of  
18 this Act; and generally relating to limousines and limousine services.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 27 MARYLAND, That Section(s) 16–402(a)(10) through (37), respectively, of Article –  
 28 Transportation of the Annotated Code of Maryland be renumbered to be Section(s)  
 29 16–402(a)(11) through (38), respectively.

30 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
 31 read as follows:

32 **Article – Public Utility Companies**

33 10–101.

34 (a) In this title the following words have the meanings indicated.

35 (e) (1) “Limousine service” means operating a motor vehicle for hire using  
 36 a motor vehicle classified as a Class Q (limousine) vehicle under § 13–939 of the  
 37 Transportation Article.

1                   (2)   “Limousine service” does not include providing taxicab services or  
2 sedan services.

3           (f)   (1)   “Operate a motor vehicle for hire” means to transport or offer to  
4 transport a person in a motor vehicle in exchange for remuneration.

5                   (2)   “Operate a motor vehicle for hire” includes:

6                           (i)   providing passenger-for-hire services; and

7                           (ii)   providing taxicab services.

8           (g)   “Provide passenger-for-hire services” includes:

9                   (1)   providing limousine services; and

10                   (2)   providing sedan services.

11           (h)   “Provide taxicab services” means to operate a motor vehicle for hire that,  
12 in addition to other services:

13                   (1)   is advertised or held out to the public as a taxicab or as providing  
14 taxicab services;

15                   (2)   regardless of how or when engaged, provides for-hire service  
16 between points chosen by the passenger and for a fare that is based on the distance  
17 traveled, the time elapsed, or both; or

18                   (3)   is engaged by the passenger for service between points chosen by  
19 the passenger that is provided through:

20                           (i)   hail from the street or other location; or

21                           (ii)   request made at a taxi stand or other location where the  
22 motor vehicle is standing and waiting for a request for service.

23           (i)   “Remuneration” includes:

24                   (1)   a fare;

25                   (2)   a fee;

26                   (3)   a toll;

27                   (4)   a gratuity; and

28                   (5)   personal services.

1 (j) (1) "Sedan service" means operating a motor vehicle for hire using a  
2 motor vehicle designed to carry 15 or fewer individuals, including the driver.

3 (2) "Sedan service" does not include providing taxicab services or  
4 limousine services.

5 10-102.

6 (b) This title applies to any motor vehicle used in the transportation of  
7 persons in exchange for remuneration except:

8 (1) motor vehicles designed to transport more than 15 persons; and

9 (2) transportation solely provided by or on behalf of a unit of federal,  
10 State, or local government, or a not-for-profit organization as identified in § 501(c)(3)  
11 and (4) of the Internal Revenue Code, that requires a criminal history records check  
12 and driving record check for its drivers, for clients of services including:

13 (i) aging support;

14 (ii) developmental and other disabilities;

15 (iii) kidney dialysis;

16 (iv) Medical Assistance Program;

17 (v) Head Start;

18 (vi) Welfare-to-Work;

19 (vii) mental health; and

20 (viii) job training.

21 10-103.

22 (a) Except as provided in subsection (b) of this section, a person may not  
23 operate a motor vehicle for hire in the State under a permit or authorization to  
24 transport passengers issued by the Commission or the appropriate local authority  
25 unless the person holds a for-hire driver's license issued by the Commission.

26 10-112.

27 (a) There is a For-Hire Driving Services Enforcement Fund.

28 (b) The Fund is a special, nonlapsing fund that is not subject to § 7-302 of  
29 the State Finance and Procurement Article.

1 (c) The purpose of the Fund is to provide adequate resources for the  
2 Commission to enforce the requirements of this title concerning for-hire driving  
3 services.

4 (d) (1) The Fund consists of assessments made on permits for vehicles  
5 regulated by the Commission to provide for-hire driving services in the State.

6 (2) The Commission shall establish an assessment not exceeding \$40  
7 to be paid annually with respect to each vehicle permit to provide for-hire driving  
8 services, except for a vehicle permit to be used exclusively for[:

9 (i) limousine service; or

10 (ii)] employee van transportation to or from a designated work  
11 site.

12 (e) The Fund is to be used solely for statewide enforcement activities of the  
13 Commission relating to taxicab services, **LIMOUSINE SERVICES**, and sedan services.

#### 14 **Article - Transportation**

16 "Limousine" means a vehicle that:

17 (1) Has been modified or stretched for transportation of passengers;  
18 [and]

19 (2) **IS DRIVEN AS PART OF A SERVICE PROVIDED BY A PERSON**  
20 **THAT ADVERTISES ITSELF AS A PROVIDER OF LIMOUSINE SERVICES OR**  
21 **REGISTERS WITH THE PUBLIC SERVICE COMMISSION AS A PROVIDER OF**  
22 **LIMOUSINE SERVICES; OR**

23 (3) Is equipped with amenities not normally provided in passenger  
24 cars, including a custom interior, television, video cassette recorder, musical sound  
25 system, telephone, ice storage area, additional interior lighting, and driver-passenger  
26 communication such as an intercom or power-operated driver partition.

27 13-939.

28 (a) When registered with the Administration, every limousine operated for  
29 hire is a Class Q (limousine) vehicle.

30 (b) For each Class Q (limousine) vehicle, the annual registration fee is  
31 \$185.00.

1 (c) On registration of a vehicle under this section, the Administration shall  
2 issue special limousine vehicle registration plates of the size and design that the  
3 Administration determines.

4 16-402.

5 (a) After the conviction of an individual for a violation of Title 2, Subtitle 5, §  
6 2-209, or § 3-211 of the Criminal Law Article, or of the vehicle laws or regulations of  
7 this State or of any local authority, points shall be assessed against the individual as  
8 of the date of violation and as follows:

9 (10) ~~OPERATING A LIMOUSINE OR ALLOWING AN INDIVIDUAL~~  
10 ~~TO OPERATE A LIMOUSINE~~ IN VIOLATION OF § 21-1127 OF THIS  
11 ARTICLE ..... 2 POINTS

13 (A) AN INDIVIDUAL MAY NOT OPERATE FOR HIRE A LIMOUSINE  
14 DESIGNED TO CARRY 15 OR FEWER INDIVIDUALS, INCLUDING THE DRIVER,  
15 UNLESS:

16 (1) THE INDIVIDUAL HOLDS A VALID FOR-HIRE DRIVER'S  
17 LICENSE ISSUED BY THE PUBLIC SERVICE COMMISSION; AND

18 (2) THE LIMOUSINE DISPLAYS SPECIAL LIMOUSINE VEHICLE  
19 REGISTRATION PLATES ISSUED UNDER § 13-939 OF THIS ARTICLE.

20 (B) A PERSON MAY NOT ALLOW AN INDIVIDUAL TO OPERATE FOR HIRE  
21 A LIMOUSINE DESIGNED TO CARRY 15 OR FEWER INDIVIDUALS, INCLUDING THE  
22 DRIVER, UNLESS:

23 (1) THE INDIVIDUAL OPERATING THE LIMOUSINE HOLDS A VALID  
24 FOR-HIRE DRIVER'S LICENSE ISSUED BY THE PUBLIC SERVICE COMMISSION;  
25 AND

26 (2) THE LIMOUSINE DISPLAYS SPECIAL LIMOUSINE VEHICLE  
27 REGISTRATION PLATES ISSUED UNDER § 13-939 OF THIS ARTICLE.

28 27-101.

29 (z) Any person who is convicted of a violation of § 21-1126 OR § 21-1127 of  
30 this article is guilty of a misdemeanor and on conviction is subject to imprisonment not  
31 exceeding 1 year or a fine not exceeding \$1,000 or both.

1           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
2   October 1, 2009.
