## A BILL ENTITLED

2 Health Occupations - Anatomic Pathology Services - Billing 3 FOR the purpose of excluding the microscopic examination of certain cells in a certain 4 test performed under certain circumstances from the definition "cytopathology" as it relates to the billing for anatomic pathology services; and 5 generally relating to anatomic pathology services. 6 7 BY repealing and reenacting, with amendments, 8 Article – Health Occupations 9 Section 1-306 10 Annotated Code of Maryland (2005 Replacement Volume and 2008 Supplement) 11 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows: 14 **Article - Health Occupations** 15 1 - 306. 16 In this section the following words have the meanings indicated. (a) (1)17 (2)"Anatomic pathology services" means: 18 (i) Histopathology or surgical pathology; 19 Cytopathology; (ii)

Subcellular pathology and molecular pathology; or

1	(v) Blood-banking services performed by pathologists.										
2 3	(3) "Clinical laboratory" means a facility that provides anatomic pathology services.										
4 5	(4) (i) "Cytopathology" means the microscopic examination of cells from fluids, aspirates, washings, brushings, or smears.										
6 7 8	(ii) "Cytopathology" includes the microscopic examination of cells in a Pap test examination performed by a physician or under the direct supervision of a physician.										
9	(5) "Hematology" means:										
10 11	(i) The microscopic evaluation of bone marrow aspirates and biopsies performed by a physician or under the direct supervision of a physician; or										
12 13	(ii) Review of a peripheral blood smear if a physician or technologist requests that a pathologist review a blood smear.										
14 15 16	(6) "Histopathology or surgical pathology" means gross and microscopic examination of organ tissue performed by a physician or under the direct supervision of a physician.										
17 18 19	(7) (i) "Referring laboratory" means a clinical laboratory that sends a specimen to another clinical laboratory for histologic processing or anatomic pathology consultation.										
20 21 22	(ii) "Referring laboratory" does not include a laboratory of a physician's office or a group practice that collects a specimen and orders, but does not perform, anatomic pathology services for patients.										
23	(b) Nothing in this section may be construed to:										
24 25	(1) Mandate the assignment of benefits for anatomic pathology services; or										
26 27 28 29 30	(2) Prohibit a health care practitioner who performs or supervises anatomic pathology services and is a member of a group practice, as defined under § 1–301 of this subtitle, from reassigning the right to bill for anatomic pathology services to the group practice if the billing complies with the requirements of subsection (c) of this section.										
31	(c) A clinical laboratory, a physician, or a group practice located in this State										

or in another state that provides anatomic pathology services for a patient in this

State shall present, or cause to be presented, a claim, bill, or demand for payment for

17 18	(1) By the health care practitioner or under the direct supervision of the health care practitioner; and								
19 20	(2) In accordance with the provisions for the preparation of biological products by service in the federal Public Health Service Act.								
21	(e) This section does not prohibit:								
22 23 24 25	(1) [a] A referring laboratory from billing for anatomic pathology services or histologic processing if the referring laboratory must send a specimen to another clinical laboratory for histologic processing or anatomic pathology consultation; AND								
26 27 28 29 30	(2) A HEALTH CARE PRACTITIONER WHO TAKES A PAP TEST SPECIMEN FROM A PATIENT AND WHO ORDERS BUT DOES NOT SUPERVISE OR PERFORM AN ANATOMIC PATHOLOGY SERVICE ON THE SPECIMEN, FROM BILLING A PATIENT OR PAYOR FOR THE SERVICE, PROVIDED THE HEALTH CARE PRACTITIONER COMPLIES WITH:

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2009.
