A BILL ENTITLED

1 AN ACT concerning

2 **Crimes – Hate Crimes – Use of a Noose or Swastika to Threaten or Intimidate**

3 FOR the purpose of prohibiting a person from affixing, erecting, or placing a noose or
4 swastika on a certain building or real property, without the express permission
5 of the owner of the building or property or the owner’s agent, with the intent to
6 threaten or intimidate any person or group of persons; establishing that a
7 certain penalty applies to a violation of this Act; and generally relating to the
8 use of a noose or swastika to threaten or intimidate a person or group of
9 persons.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

1 **A PERSON MAY NOT AFFIX, ERECT, OR PLACE A NOOSE OR SWASTIKA ON A**
2 **BUILDING OR REAL PROPERTY, PUBLIC OR PRIVATE, WITHOUT THE EXPRESS**
3 **PERMISSION OF THE OWNER, OWNER'S AGENT, OR LAWFUL OCCUPANT OF THE**
4 **BUILDING OR REAL PROPERTY, WITH THE INTENT TO THREATEN OR INTIMIDATE**
5 **ANY PERSON OR GROUP OF PERSONS.**

7 (a) Except as provided in subsection (b) of this section, a person who violates
8 this subtitle is guilty of a misdemeanor and on conviction is subject to imprisonment
9 not exceeding 3 years or a fine not exceeding \$5,000 or both.

10 (b) (1) A person who violates § 10-304(2)(i) of this subtitle is guilty of a
11 felony and on conviction is subject to imprisonment not exceeding 10 years or a fine
12 not exceeding \$10,000 or both.

13 (2) A person who violates § 10-304(2)(ii) of this subtitle is guilty of a
14 felony and on conviction is subject to imprisonment not exceeding 20 years or a fine
15 not exceeding \$20,000 or both.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2009.
