- FOR the purpose of altering the maximum limit of the value of the raffle tickets that an individual may purchase in connection with campaign fundraising activity conducted by certain persons; prohibiting the use of cash to purchase raffle tickets exceeding a certain value in connection with campaign fundraising conducted by certain persons; and generally relating to limits on the purchase of raffle tickets in connection with campaign fundraising activity.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 15 MARYLAND, That the Laws of Maryland read as follows:

- 18 (a) (1) Notwithstanding any other provision of this subtitle, Subtitle 2 of this title, or Title 13 of this article and except as otherwise provided in this subsection, 20 a bona fide charitable organization in this State may conduct a raffle for the exclusive
- 21 benefit of the charitable organization if the prize awarded is real property:
- 22 (i) to which the charitable organization holds title; or
- 23 (ii) for which the charitable organization has the ability to

1 A charitable organization may not conduct more than two raffles of (2)2 real property in a calendar year. The Secretary of State may adopt regulations governing a raffle of 3 (3)real property by a charitable organization under this subsection. 4 5 Notwithstanding any other provision of this article and except as (b) **(1)** 6 otherwise provided in this subsection, a political committee or candidate for public 7 office may conduct a raffle if the prizes awarded are money or merchandise. 8 (2)(i) The cost of a raffle ticket under this subsection may not 9 exceed \$5. 10 [An] EXCEPT AS PROVIDED IN SUBPARAGRAPH (III) OF (ii) 11 THIS PARAGRAPH, AN individual may not purchase more than \$50 worth of tickets. 12 (III) AN INDIVIDUAL MAY PURCHASE MORE THAN \$50 13 WORTH OF TICKETS BUT NOT MORE THAN \$100 WORTH OF TICKETS, PROVIDED 14 THE SALES TRANSACTION DOES NOT INCLUDE MORE THAN \$50 IN CASH. This subsection does not relieve a political committee or candidate 15 (3)from the reporting and record keeping requirements under the Election Law Article. 16

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
