A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City Charter – East Baltimore Community Benefits District**

3 FOR the purpose of authorizing the Mayor and City Council of Baltimore to establish
4 by ordinance the East Baltimore Community Benefits District to provide certain
5 services; authorizing the Mayor and City Council to establish the East
6 Baltimore Community Benefits District Authority to provide certain services;
7 requiring a certain ordinance to provide the method for establishing certain
8 boundaries; requiring a certain ordinance to specify certain taxes; providing for
9 the appointment of officers and board members of the East Baltimore
10 Community Benefits District; requiring a certain financial plan to be subject to
11 approval by the Baltimore City Board of Estimates; providing certain
12 limitations, powers, and duties of the East Baltimore Community Benefits
13 District Authority; requiring the Mayor and City Council to take certain
14 matters into consideration when enacting certain ordinances; prohibiting the
15 Mayor and City Council from authorizing certain reductions in services;
16 providing for the reversion of unspent funds under a certain condition; placing a
17 certain condition on a certain ordinance taking effect; and generally relating to
18 the establishment of the East Baltimore Community Benefits District.

21 Article II – General Powers

22 Section (65)

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
25 MARYLAND, That the Laws of Maryland read as follows:

26 **The Charter of Baltimore City**

27 Article II – General Powers

1 The Mayor and City Council of Baltimore shall have full power and authority to
2 exercise all of the powers heretofore or hereafter granted to it by the Constitution of
3 Maryland or by any Public General or Public Local Laws of the State of Maryland; and
4 in particular, without limitation upon the foregoing, shall have power by ordinance, or
5 such other method as may be provided for in its Charter, subject to the provisions of
6 said Constitution and Public General Laws:

8 **(A) SUBJECT TO SUBSECTION (M) OF THIS SECTION, THE CITY MAY:**

9 **(1) ESTABLISH, BY ORDINANCE, THE EAST BALTIMORE**
10 **COMMUNITY BENEFITS DISTRICT WITHIN THE CITY OF BALTIMORE TO**
11 **PROVIDE SERVICES CONSISTENT WITH PARAGRAPH (2) OF THIS SUBSECTION TO**
12 **THE BUSINESSES AND RESIDENTS OF THE PROPOSED DISTRICT; AND**

13 **(2) ESTABLISH, BY ORDINANCE, THE EAST BALTIMORE**
14 **COMMUNITY BENEFITS DISTRICT AUTHORITY TO:**

15 **(I) PROMOTE AND MARKET THE EAST BALTIMORE**
16 **COMMUNITY BENEFITS DISTRICT;**

17 **(II) PROVIDE SUPPLEMENTAL SECURITY AND**
18 **MAINTENANCE SERVICES;**

19 **(III) PROVIDE AMENITIES IN PUBLIC AREAS;**

20 **(IV) PROVIDE PARK AND RECREATIONAL PROGRAMS AND**
21 **FUNCTIONS; AND**

22 **(V) PROVIDE OTHER SERVICES AND FUNCTIONS AS**
23 **REQUESTED BY THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT**
24 **AUTHORITY APPROVED BY AN ORDINANCE OF THE MAYOR AND CITY COUNCIL**
25 **OF BALTIMORE.**

26 **(B) THE ORDINANCE ESTABLISHING THE EAST BALTIMORE**
27 **COMMUNITY BENEFITS DISTRICT SHALL:**

28 **(1) SPECIFY THE METHOD FOR ESTABLISHING AND MODIFYING**
29 **THE BOUNDARIES OF THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT;**

30 **(2) SPECIFY THE POWERS AND FUNCTIONS WITHIN THE LIMITS OF**
31 **THIS SECTION, THAT MAY BE EXERCISED AND CONDUCTED BY THE EAST**
32 **BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY;**

1 **(3) SPECIFY THE AMOUNT OF TAXES OR CHARGES THAT MAY BE**
2 **IMPOSED ON PROPERTIES IN THE EAST BALTIMORE COMMUNITY BENEFITS**
3 **DISTRICT;**

4 **(4) SPECIFY THE DURATION OF THE EAST BALTIMORE**
5 **COMMUNITY BENEFITS DISTRICT AUTHORITY;**

6 **(5) PROVIDE FOR THE IMPOSITION AND COLLECTION OF THE**
7 **TAXES OR CHARGES AND FOR DISBURSEMENT OF THE REVENUE TO THE EAST**
8 **BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY SUBJECT TO**
9 **SUBSECTION (D) OF THIS SECTION;**

10 **(6) DETERMINE WHAT CLASSES AND SUBCLASSES OF PROPERTY**
11 **IN THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT SHALL BE SUBJECT**
12 **TO OR EXEMPT FROM TAXES OR CHARGES UNDER THIS SECTION;**

13 **(7) SPECIFY THE METHOD FOR DETERMINING THE TAXES OR**
14 **CHARGES TO BE IMPOSED ON CLASSES AND SUBCLASSES OF PROPERTY UNDER**
15 **THIS SECTION; AND**

16 **(8) DETERMINE THE ORGANIZATION AND METHOD OF INITIAL**
17 **APPOINTMENT OF OFFICERS AND BOARD MEMBERS OF THE EAST BALTIMORE**
18 **COMMUNITY BENEFITS DISTRICT AUTHORITY, SUBJECT TO SUBSECTION (E) OF**
19 **THIS SECTION.**

20 **(C) THE FINANCIAL PLAN OF THE EAST BALTIMORE COMMUNITY**
21 **BENEFITS DISTRICT AUTHORITY, INCLUDING ITS ANNUAL BUDGET, TAX RATE,**
22 **AND SCHEDULE OF CHARGES, SHALL BE SUBJECT TO APPROVAL BY THE BOARD**
23 **OF ESTIMATES.**

24 **(D) (1) BEFORE ADOPTING ITS PROPOSED BUDGET AND MAKING ITS**
25 **RECOMMENDATIONS TO THE CITY, THE EAST BALTIMORE COMMUNITY**
26 **BENEFITS DISTRICT AUTHORITY SHALL HOLD A PUBLIC HEARING ON TAXES OR**
27 **CHARGES PROPOSED FOR THE EAST BALTIMORE COMMUNITY BENEFITS**
28 **DISTRICT.**

29 **(2) THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT**
30 **AUTHORITY SHALL PUBLISH NOTICE OF THE HEARING UNDER PARAGRAPH (1)**
31 **OF THIS SUBSECTION IN A NEWSPAPER OF GENERAL CIRCULATION IN**
32 **BALTIMORE CITY AT LEAST ONCE A WEEK FOR 3 CONSECUTIVE WEEKS BEFORE**
33 **THE HEARING.**

1 **(3) PROPERTY IN THE EAST BALTIMORE COMMUNITY BENEFITS**
2 **DISTRICT THAT IS EXEMPT UNDER STATE LAW FROM ORDINARY PROPERTY**
3 **TAXES SHALL BE EXEMPT FROM TAXES OR CHARGES ASSESSED TO SUPPORT**
4 **THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY.**

5 **(4) THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT**
6 **AUTHORITY MAY REQUEST THE OWNERS OF PROPERTY EXEMPT FROM TAXES**
7 **UNDER PARAGRAPH (3) OF THIS SUBSECTION TO CONTRIBUTE TO THE COSTS OF**
8 **THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY.**

9 **(5) TAXES AND CHARGES IMPOSED UNDER AN ORDINANCE**
10 **ENACTED UNDER SUBSECTION (B)(3) OF THIS SECTION MAY NOT EXCEED THE**
11 **TAXES AND CHARGES PROPOSED BY THE EAST BALTIMORE COMMUNITY**
12 **BENEFITS DISTRICT AUTHORITY.**

13 **(E) (1) THE MAJORITY OF THE MEMBERS OF THE BOARD SHALL BE**
14 **OWNERS OR REPRESENTATIVES OF OWNERS OF PROPERTIES IN THE EAST**
15 **BALTIMORE COMMUNITY BENEFITS DISTRICT THAT ARE SUBJECT TO TAXES OR**
16 **CHARGES UNDER THIS SECTION.**

17 **(2) A VOTING MEMBER OF THE BOARD MUST BE ELIGIBLE TO**
18 **VOTE IN THE ELECTION UNDER SUBSECTION (M) OF THIS SECTION.**

19 **(F) AS PROVIDED BY ORDINANCE ENACTED UNDER THIS SECTION, THE**
20 **EAST BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY SHALL HAVE**
21 **THE POWER TO:**

22 **(1) CONDUCT THE FUNCTIONS WHICH ARE ASSIGNED TO IT BY**
23 **THE CITY;**

24 **(2) ACQUIRE, HOLD, AND USE PROPERTY NECESSARY TO ACHIEVE**
25 **ITS PURPOSES;**

26 **(3) ENTER INTO CONTRACTS;**

27 **(4) SUE AND BE SUED, SUBJECT TO SUBSECTION (G) OF THIS**
28 **SECTION;**

29 **(5) BORROW AND ACCEPT GRANTS FOR PURPOSES CONSISTENT**
30 **WITH THE PURPOSES OF THE EAST BALTIMORE COMMUNITY BENEFITS**
31 **DISTRICT AUTHORITY;**

32 **(6) EMPLOY AND DISCHARGE PERSONNEL TO CARRY OUT ITS**
33 **PUBLIC PURPOSES;**

1 **(7) PROPOSE IN ITS ANNUAL BUDGET THE TAXES OR CHARGES ON**
2 **PROPERTY WITHIN THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT IN**
3 **ACCORDANCE WITH SUBSECTION (D) OF THIS SECTION;**

4 **(8) ADOPT, AMEND, AND MODIFY BYLAWS, ALL OF WHICH SHALL**
5 **BE SUBJECT TO THE APPROVAL OF THE BOARD OF ESTIMATES;**

6 **(9) ESTABLISH AND ELECT OFFICERS AND PROVIDE FOR THEIR**
7 **TERMS AND DUTIES;**

8 **(10) CONTRACT FOR AND PURCHASE GOODS AND SERVICES IN**
9 **ACCORDANCE WITH SUBSECTION (H) OF THIS SECTION; AND**

10 **(11) DO ALL THINGS NECESSARY OR CONVENIENT TO CARRY OUT**
11 **ITS POWERS.**

12 **(G) THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT, EAST**
13 **BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY, ITS BOARD OF**
14 **DIRECTORS, AND ANY ADMINISTRATOR OF THE EAST BALTIMORE COMMUNITY**
15 **BENEFITS DISTRICT SHALL BENEFIT, TO THE FULLEST EXTENT ALLOWABLE BY**
16 **LAW, FROM ALL PROVISIONS OF FEDERAL, STATE, AND LOCAL LAW LIMITING**
17 **THE LIABILITY OF EMPLOYEES, OFFICERS, AGENTS, AND OFFICIALS OF**
18 **GOVERNMENTAL BODIES.**

19 **(H) (1) EXCEPT AS PROVIDED UNDER PARAGRAPH (2) OF THIS**
20 **SUBSECTION, A CONTRACT ENTERED INTO UNDER SUBSECTION (F)(10) OF THIS**
21 **SECTION IS NOT SUBJECT TO THE CITY REQUIREMENTS REGARDING WAGE**
22 **SCALES, COMPETITIVE BIDDING, OR OTHER LOCAL PROCUREMENT LAWS.**

23 **(2) THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT**
24 **AUTHORITY SHALL BE SUBJECT TO CITY ORDINANCES AND CITY POLICY**
25 **REQUIRING ACHIEVEMENT OF GOALS REGARDING MINORITY AND WOMEN'S**
26 **BUSINESS ENTERPRISES.**

27 **(I) AS PROVIDED BY ORDINANCE ENACTED UNDER THIS SECTION, THE**
28 **EAST BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY MAY NOT:**

29 **(1) EXERCISE ANY POLICE OR GENERAL POWERS OTHER THAN**
30 **THOSE AUTHORIZED BY STATE LAW AND CITY ORDINANCE;**

31 **(2) PLEDGE THE FULL FAITH OR CREDIT OF THE CITY;**

1 **(3) IMPOSE TAXES OR CHARGES IN EXCESS OF THOSE APPROVED**
2 **BY THE BOARD OF ESTIMATES;**

3 **(4) EXERCISE THE POWER OF EMINENT DOMAIN;**

4 **(5) ENGAGE IN COMPETITION WITH THE PRIVATE SECTOR,**
5 **EXCEPT AS OTHERWISE PROVIDED BY LAW, AND AS NECESSARY TO EXERCISE**
6 **THE POWERS PROVIDED FOR HEREIN AND IN ANY ORDINANCE ENACTED WITH**
7 **RESPECT TO THE EAST BALTIMORE COMMUNITY BENEFITS DISTRICT OR THE**
8 **EAST BALTIMORE COMMUNITY BENEFITS DISTRICT AUTHORITY;**

9 **(6) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (L) OF THIS**
10 **SECTION, REVERT CHARGES OR TAXES COLLECTED PURSUANT TO THIS SECTION**
11 **TO THE GENERAL FUND OF THE CITY;**

12 **(7) BE AN AGENCY OF THE MAYOR AND CITY COUNCIL OF**
13 **BALTIMORE OR THE STATE OF MARYLAND, AND ITS OFFICERS AND EMPLOYEES**
14 **MAY NOT ACT AS AGENTS OR EMPLOYEES OF THE MAYOR AND CITY COUNCIL OF**
15 **BALTIMORE OR THE STATE OF MARYLAND;**

16 **(8) EMPLOY INDIVIDUALS WHO RESIDE OUTSIDE THE CITY OF**
17 **BALTIMORE; AND**

18 **(9) EXCEPT AS REQUIRED OR APPROPRIATE TO FACILITATE ITS**
19 **NORMAL OPERATIONS, INCUR DEBT.**

20 **(J) IN ENACTING AN ORDINANCE IN ACCORDANCE WITH THIS SECTION,**
21 **THE MAYOR AND CITY COUNCIL OF BALTIMORE SHALL:**

22 **(1) GIVE CONSIDERATION TO THE VIEWS OF THE PROPERTY**
23 **OWNERS, THE RETAIL MERCHANTS, THE PROPERTY TENANTS, AND THE OTHER**
24 **MEMBERS OF THE BUSINESS AND RESIDENTIAL COMMUNITIES WITHIN THE**
25 **EAST BALTIMORE COMMUNITY BENEFITS DISTRICT;**

26 **(2) MAKE A DETERMINATION THAT THE EAST BALTIMORE**
27 **COMMUNITY BENEFITS DISTRICT CREATED UNDER THIS SECTION WILL**
28 **REFLECT A DIVERSE MIX OF BUSINESS AND RESIDENTIAL PROPERTIES; AND**

29 **(3) MAKE A DETERMINATION THAT THE EAST BALTIMORE**
30 **COMMUNITY BENEFITS DISTRICT CREATED UNDER THIS SECTION WILL**
31 **REFLECT A DIVERSE ECONOMIC, SOCIAL, AND RACIAL MIX.**

1 **(K) THE MAYOR AND CITY COUNCIL OF BALTIMORE MAY NOT PERMIT A**
2 **REDUCTION IN THE SERVICES PROVIDED BY THE CITY IN THE EAST BALTIMORE**
3 **COMMUNITY BENEFITS DISTRICT.**

4 **(L) IN THE EVENT OF A DISSOLUTION OF THE EAST BALTIMORE**
5 **COMMUNITY BENEFITS DISTRICT, ANY UNSPENT FUNDS SHALL REVERT BACK**
6 **TO THE CITY'S GENERAL FUND.**

7 **(M) (1) AN ORDINANCE ENACTED PURSUANT TO SUBSECTION (A) OF**
8 **THIS SECTION SHALL TAKE EFFECT ONLY IF IT IS APPROVED BY 58% OF THE**
9 **AGGREGATE VOTES CAST IN A SPECIAL ELECTION BY THE AFFECTED VOTERS.**

10 **(2) THE ORDINANCE SHALL PROVIDE:**

11 **(I) CRITERIA FOR THE ELIGIBILITY OF VOTERS FOR**
12 **PURPOSES OF THE ELECTION REQUIRED BY THIS SUBSECTION; AND**

13 **(II) PROCEDURES FOR A SPECIAL ELECTION REQUIRED IN**
14 **THIS SUBSECTION, WHICH MAY BE ADMINISTERED BY WRITE-IN BALLOTS.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 June 1, 2009.
