#### 1 AN ACT concerning

## Family Law - State Citizens Review Board for Children and Local Boards of Review - Duties

4 FOR the purpose of altering the cases required to be reviewed by the State Citizens Review Board for Children and local boards of review for children in 5 6 out-of-home care; requiring the State Board to tabulate certain results and 7 submit them to the Department of Human Resources; altering the requirements 8 for certain community forums; altering the frequency of certain case reviews by 9 local boards; altering the findings and recommendations required to be included 10 in certain reports; repealing a requirement that a local board explain a certain 11 finding; repealing a provision authorizing certain case reviews to include certain questions; and generally relating to the State Citizens Review Board for 12 Children and local boards of review. 13
