A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Anne Arundel County –**
3 **Tipton Airport Control Tower**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005
5 to change the purpose of the Tipton Airport Control Tower grant to the
6 Benson–Hammond House Renovation; changing the grantee to the Board of
7 Directors of the Anne Arundel County Historical Society, Inc.; altering the
8 authorized uses of the grant; altering the location of the project; altering the
9 requirement that the grantee provide a certain matching fund; and generally
10 relating to amending the Maryland Consolidated Capital Bond Loan of 2005 to
11 alter the purpose of a certain grant.

12 BY repealing and reenacting, with amendments,
13 Chapter 445 of the Acts of the General Assembly of 2005
14 Section 1(3) Item ZA02(K)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That:

20 (3) ZA02 LOCAL SENATE INITIATIVES

21 (K) [Tipton Airport Control Tower.] **BENSON–HAMMOND**
22 **HOUSE RENOVATION.** Provide a grant equal to the lesser of
23 (i) \$100,000 or (ii) the amount of the matching fund provided,
24 to the [Anne Arundel County Tipton Airport Authority]

1 **BOARD OF DIRECTORS OF THE ANNE ARUNDEL COUNTY**
2 **HISTORICAL SOCIETY, INC.** for the **REPAIR**, renovation,
3 **RECONSTRUCTION, AND CAPITAL EQUIPPING** of the
4 [control tower at Tipton Airport for use as an educational
5 exhibit and organizational meeting place]
6 **BENSON-HAMMOND HOUSE AND RELATED**
7 **OUTBUILDINGS**, located in [Odenton] **LINTHICUM**.
8 Notwithstanding Section 1(5) of this Act, the matching fund
9 may consist of **REAL PROPERTY, IN KIND CONTRIBUTIONS,**
10 **OR** funds expended prior to the effective date of this Act
11 (Anne Arundel County) 100,000

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 June 1, 2009.
