8 employee's criminal history record information under certain circumstances;

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article - Human Services**

1 (a) (1) Within the first month of employment with the Department, the
2 Department shall apply to the Criminal Justice Information System Central
3 Repository in the Department of Public Safety and Correctional Services for a federal
4 and State criminal history records check for each employee of the Department.

5 (2) The Criminal Justice Information System Central Repository shall
6 provide the requested information in accordance with Title 10, Subtitle 2 of the
7 Criminal Procedure Article.

8 (3) **IF CRIMINAL HISTORY RECORD INFORMATION IS REPORTED**
9 **TO THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY**
10 **AFTER THE DATE OF THE CRIMINAL HISTORY RECORDS CHECK, THE CRIMINAL**
11 **JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY SHALL PROVIDE TO**
12 **THE DEPARTMENT AND THE EMPLOYEE A REVISED PRINTED STATEMENT OF**
13 **THE EMPLOYEE’S CRIMINAL HISTORY RECORD INFORMATION.**

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2009.
