CHAPTER _____

1 AN ACT concerning

2 **Criminal Procedure – Criminal Injuries Compensation Board – Claims by**
3 **Victims Outside of the United States**

4 FOR the purpose of altering the definition of “crime” for purposes of the Criminal
5 Injuries Compensation Board to make residents of the State against whom
6 certain acts are committed outside of the United States or a territory or
7 commonwealth of the United States eligible for an award from the Board; and
8 generally relating to eligibility for awards from the Criminal Injuries
9 Compensation Board.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Criminal Procedure**

18 11–801.

19 (a) In this subtitle the following words have the meanings indicated.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

~~Strike-out~~ indicates matter stricken from the bill by amendment or deleted from the law by amendment.



1 (b) “Board” means the Criminal Injuries Compensation Board.

2 (c) “Claimant” means the person filing a claim under this subtitle.

3 (d) (1) “Crime” means:

4 (i) except as provided in paragraph (2) of this subsection, a
5 criminal offense under state, federal, or common law that is committed in:

6 1. this State; or

7 2. another state against a resident of this State; [or]

8 (ii) **AN ACT COMMITTED AGAINST A RESIDENT OF THIS**
9 **STATE OUTSIDE OF THE UNITED STATES OR A TERRITORY OR COMMONWEALTH**
10 **OF THE UNITED STATES THAT, IF COMMITTED IN THE UNITED STATES OR A**
11 **TERRITORY OR COMMONWEALTH OF THE UNITED STATES, WOULD CONSTITUTE**
12 **A CRIMINAL OFFENSE UNDER STATE, FEDERAL, OR COMMON LAW; OR**

13 (iii) an act of international terrorism as defined in Title 18, §
14 2331 of the United States Code that is committed outside of the United States against
15 a resident of this State.

16 (2) “Crime” does not include an act involving the operation of a vessel
17 or motor vehicle unless the act is:

18 (i) a violation of § 20–102, § 20–104, § 21–902, or § 21–904 of
19 the Transportation Article; or

20 (ii) operating a motor vehicle or vessel that results in an
21 intentional injury.

22 (e) “Dependent” means:

23 (1) a surviving spouse or child of a person; or

24 (2) a person who is dependent on another person for principal support.

25 (f) “Victim” means a person:

26 (1) who suffers physical injury or death as a result of a crime or
27 delinquent act;

28 (2) who suffers psychological injury as a direct result of:

1 (i) a fourth degree sexual offense or a delinquent act that would
2 be a fourth degree sexual offense if committed by an adult;

3 (ii) a felony or a delinquent act that would be a felony if
4 committed by an adult; or

5 (iii) physical injury or death directly resulting from a crime or
6 delinquent act; or

7 (3) who suffers physical injury or death as a direct result of:

8 (i) trying to prevent a crime or delinquent act or an attempted
9 crime or delinquent act from occurring in the person's presence;

10 (ii) trying to apprehend an offender who had committed a crime
11 or delinquent act in the person's presence or had committed a felony or a delinquent
12 act that would be a felony if committed by an adult; or

13 (iii) helping a law enforcement officer in the performance of the
14 officer's duties or helping a member of a fire department who is being obstructed from
15 performing the member's duties.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
17 October 1, 2009.
