## A BILL ENTITLED

1 AN ACT concerning

2 **Business and Economic Development - Maryland Public Art Initiative -**  
3 **Sunset Repeal**

4 FOR the purpose of repealing the termination provision applicable to the Maryland  
5 Public Art Initiative Program, the Maryland Public Art Fund, and the Maryland  
6 Commission on Public Art within the Department of Business and Economic  
7 Development; and generally relating to the Maryland Public Art Initiative  
8 Program, the Maryland Public Art Fund, and the Maryland Commission on  
9 Public Art.

10 BY repealing and reenacting, with amendments,  
11 Chapter 393 of the Acts of the General Assembly of 2005  
12 Section 2

13 BY repealing  
14 Chapter 306 of the Acts of the General Assembly of 2008  
15 Section 21

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Chapter 393 of the Acts of 2005**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 June 1, 2005. [It shall remain effective for a period of 5 years and, at the end of May  
21 31, 2010, with no further action required by the General Assembly, this Act shall be  
22 abrogated and of no further force and effect.]

1           [SECTION 21. AND BE IT FURTHER ENACTED, That Title 4, Subtitle 6, of  
2 the Economic Development Article and the subtitle “Subtitle 6. Maryland Public Art  
3 Initiative Program” as enacted by Section 2 of this Act, shall remain effective until the  
4 taking effect of the termination provision specified in Section 2 of Chapter 393 of the  
5 Acts of the General Assembly of 2005. If that termination provision takes effect, Title  
6 4, Subtitle 6 of the Economic Development Article and the subtitle “Subtitle 6.  
7 Maryland Public Art Initiative Program”, as enacted by Section 2 of this Act, shall be  
8 abrogated and of no further force and effect. This Act may not be interpreted to have  
9 any effect on that termination provision.]

10           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
11 October 1, 2009.
