Department of Labor, Licensing, and Regulation – Maryland Real Estate Commission – Continuing Education

4 FOR the purpose of requiring additional continuing education course hours for the 5 renewal of certain real estate licenses; repealing certain exceptions for certain 6 real estate licensees who have been licensed a certain minimum number of 7 vears; altering certain continuing education requirements for a licensee who possesses a certain graduate degree; altering the criteria for the Maryland Real 8 9 Estate Commission to use in selecting subject matter for continuing education courses; granting the Commission the authority to charge certain fees; and 10 generally relating to continuing education for real estate licensees. 11
