SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 18 19 MARYLAND, That the Laws of Maryland read as follows:

The following funds held by any utility are presumed abandoned:

6 (1) Any deposit made by a subscriber with a utility to secure payment 7 for, or any sum paid in advance for, utility services to be furnished in the State, less 8 any lawful deduction, that has remained unclaimed by the person who appears on the 9 records of the utility as entitled to it for more than 3 years after the termination of the 10 services for which the deposit or advance payment was made;

11 (2) Any sum which a utility has been ordered to refund and which was 12 received for utility services rendered in the State, together with any interest on it, less 13 any lawful deduction, that has remained unclaimed by the person appearing on the 14 records of the utility as entitled to it for more than 3 years after the date it became 15 payable in accordance with the final determination or order providing for the refund; 16 and

17 (3) Any sum paid to a utility for a utility service, which service has not18 been rendered within 3 years of the payment.

(a) (1) All funds received under this title, including the proceeds of the
sale of abandoned property under § 17–316 of this subtitle, shall be credited by the
Administrator to a special fund. The Administrator shall retain in the special fund at
the end of each fiscal year, from the proceeds received, an amount not to exceed
\$50,000, from which sum the Administrator shall pay any claim allowed under this
title.

3 (ii) If a victim entitled to restitution that has been treated as 4 abandoned property under § 11–614 of the Criminal Procedure Article is located after 5 the money has been distributed under this paragraph, the Administrator shall reduce 6 the next distribution to the State Victims of Crime Fund by the amount recovered by 7 the victim.

8 (4) After making the distributions required under paragraphs (2) and 9 (3) of this subsection, the Administrator shall distribute the remaining net funds not 10 retained under paragraph (1) of this subsection to the General Fund of the State.

11 (b) Before making the distribution, the Administrator shall record the name 12 and last known address, if any, of the owners of funds so distributed and the type of 13 property which the funds distributed represent. The record shall be available for 14 public inspection during reasonable business hours by any person who claims a legal 15 interest in any property held by the Administrator, provided that the person gives 16 prior notice to the Administrator.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2009.
