## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loans of 2005 and 2006 – St. Mary’s**  
3 **County – Sotterley Plantation**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loans of 2005  
5 and 2006 to change the name of a certain grantee, alter the purposes of certain  
6 grants, and extend the date by which a certain grantee must present evidence  
7 that a certain matching fund will be provided; and generally relating to  
8 amending the Maryland Consolidated Capital Bond Loans of 2005 and 2006.

9 BY repealing and reenacting, with amendments,  
10 Chapter 445 of the Acts of the General Assembly of 2005, as amended by  
11 Chapter 85 of the Acts of the General Assembly of 2007  
12 Section 1(3) Item ZA01(BM)

13 BY repealing and reenacting, with amendments,  
14 Chapter 46 of the Acts of the General Assembly of 2006  
15 Section 1(3) Item ZA02(BY)

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That the Laws of Maryland read as follows:

18 **Chapter 445 of the Acts of 2005, as amended by Chapter 85 of the Acts of 2007**

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That:

21 (3) ZA01 LOCAL HOUSE OF DELEGATES INITIATIVES

22 (BM) Sotterley Plantation. Provide a grant equal to the lesser of (i)  
23 \$50,000 or (ii) the amount of the matching fund provided, to  
24 the Board of Directors of **HISTORIC** Sotterley [Foundation,],

1 Inc. for the planning, design, acquisition, construction,  
 2 installation, and capital equipping of [security upgrades]  
 3 **EXISTING FACILITIES** for Sotterley Plantation, located in  
 4 Hollywood, subject to a requirement that the grantee grant  
 5 and convey an historic easement to the Maryland Historical  
 6 Trust. Notwithstanding Section 1(5) of this Act, the matching  
 7 fund may consist of in kind contributions and the grantee  
 8 must present evidence that a matching fund will be provided  
 9 by June 1, [2009] **2011** (St. Mary’s County) ..... 50,000

**Chapter 46 of the Acts of 2006**

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
12 MARYLAND, That:

13 (3) ZA02 LOCAL HOUSE OF DELEGATES INITIATIVES

14 (BY) Sotterley Plantation. Provide a grant equal to the lesser of (i)  
 15 \$50,000 or (ii) the amount of the matching fund provided, to  
 16 the Board of Directors of the **HISTORIC** Sotterley  
 17 [Foundation,], Inc. for the [repair, renovation, reconstruction,  
 18 and demolition of outbuildings at] **PLANNING, DESIGN,**  
 19 **ACQUISITION, CONSTRUCTION, INSTALLATION, AND**  
 20 **CAPITAL EQUIPPING OF EXISTING FACILITIES FOR**  
 21 Sotterley Plantation, located in Hollywood, subject to a  
 22 requirement that the grantee grant and convey a historic  
 23 easement to the Maryland Historical Trust. Notwithstanding  
 24 Section 1(5) of this Act, the matching fund may consist of in  
 25 kind contributions **AND THE GRANTEE MUST PRESENT**  
 26 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED**  
 27 **BY JUNE 1, 2011** (St. Mary’s County) ..... 50,000

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
29 June 1, 2009.
