1 AN ACT concerning

Financial Exploitation Prevention Act of 2009

3 FOR the purpose of altering the definition of "vulnerable adult" to include a person 4 who lacks a certain capacity to consent for purposes of certain prohibitions 5 against causing certain abuse or neglect or sexual abuse of a certain vulnerable 6 adult; prohibiting a person from knowingly and willfully obtaining by a certain 7 illusory consent the property of an individual that the person knows or reasonably should know is a vulnerable adult with intent to deprive the 8 9 vulnerable adult of the vulnerable adult's property; defining certain terms; and 10 generally relating to vulnerable adults.
