A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Montgomery County**
3 **– Agriculture Activity Center Expansion**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007
5 to change the grantee of a certain project from the County Executive and
6 County Council of Montgomery County to the Maryland–National Capital Park
7 and Planning Commission and extend the deadline by which the grantee may
8 present evidence to the Board of Public Works that a matching fund will be
9 provided for the Agriculture Activity Center Expansion.

10 BY repealing and reenacting, with amendments,
11 Chapter 488 of the Acts of the General Assembly of 2007
12 Section 1(3) Item ZA01(AM) and Item ZA02(AW)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:
