## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **State Fire Marshal – Fire Sprinkler Contractor – Licensing**

3 FOR the purpose of repealing a certain provision that allowed certain contractors to  
4 provide certain services as fire sprinkler contractors without being licensed by  
5 the State Fire Marshal; and generally relating to licensing of persons providing  
6 fire sprinkler services by the State Fire Marshal.

7 BY repealing and reenacting, with amendments,  
8 Article – Public Safety  
9 Section 9–903  
10 Annotated Code of Maryland  
11 (2003 Volume and 2008 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 9–903.

16 (a) Except as provided in subsection (b) of this section, a person may not  
17 provide services as a fire sprinkler contractor in the State unless the person[:

1 (1)] is licensed by the State Fire Marshal[; or

2 (2) is a contractor of a person who is licensed by the State Fire  
3 Marshal].

4 (b) This subtitle does not prohibit:

5 (1) inspections and tests of fire sprinkler systems by insurance  
6 representatives if the representatives are acting in the performance of their assigned  
7 duties;

8 (2) inspections, tests, and repairs of fire sprinkler systems by full-time  
9 maintenance employees of a property owner if the employees:

10 (i) are knowledgeable about fire sprinkler systems; and

11 (ii) are acting in the performance of their assigned duties for the  
12 property owner;

13 (3) inspections, tests, plan review, and ensuring the maintenance of  
14 fire sprinkler systems, emergency maintenance activity on fire sprinkler systems, or  
15 restoration to active service of operating or recently operated fire sprinkler systems by  
16 members of State, county, municipal, career, or volunteer fire departments, or  
17 authorities with jurisdiction if the members are acting in their capacity as members of  
18 the fire departments or authorities;

19 (4) installation of limited area fire sprinkler systems or emergency  
20 temporary repairs on fire sprinkler systems performed by master plumbers if the  
21 plumbers are acting in accordance with regulations adopted by the State Fire  
22 Prevention Commission; or

23 (5) inspections, tests, preparation of design and specification  
24 documents, hydraulic calculations, layout, and plan review of fire sprinkler systems by  
25 Maryland professional engineers if the engineers are knowledgeable about fire  
26 sprinkler systems.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
28 October 1, 2009.
