### A BILL ENTITLED

#### 1 AN ACT concerning

# Task Force to Study Merging the Cecil County Health Department, Social Services Department, and Senior Services & Community Transit Department

- 4 FOR the purpose of establishing a Task Force to Study Merging the Cecil County 5 Health Department, Social Services Department, and Senior Services & 6 Community Transit Department; providing for the membership and duties of the Task Force; providing for the staffing of the Task Force; prohibiting a 7 8 member of the Task Force from receiving certain compensation; authorizing a 9 member of the Task Force to receive reimbursement for certain expenses; 10 requiring the Task Force to prepare certain reports; requiring a certain report 11 to be sent to the County Commissioners of Cecil County; requiring copies of a certain report to be sent to certain State agencies; providing for the termination 12 of this Act; and generally relating to the Task Force to Study Merging the Cecil 13 14 County Health Department, Social Services Department, and Senior Services & 15Community Transit Department.
- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 17 MARYLAND, That:
- (a) There is a Task Force to Study Merging the Cecil County Health
  Department, Social Services Department, and Senior Services & Community Transit
  Department.
- 21 (b) The Task Force consists of the following members:

(1) two representatives from the Cecil County Health Department,
 appointed jointly by the County Commissioners of Cecil County and the Director of the
 Cecil County Health Department;

4 (3) two representatives from the Cecil County Senior Services & 5 Community Transit Department, appointed jointly by the County Commissioners of 6 Cecil County and the Director of the Cecil County Senior Services & Community 7 Transit Department;

8 (4) two representatives from the Cecil County Social Services Board, 9 appointed jointly by the County Commissioners of Cecil County and the Chairman of 10 the Cecil County Family Services Board;

11 (5) two individuals from a nonprofit senior citizens organization that 12 operates in Cecil County, appointed by the County Commissioners of Cecil County;

13 (6) one representative from the Maryland Department of Health and
 14 Mental Hygiene, appointed jointly by the County Commissioners of Cecil County and
 15 the Secretary of Health and Mental Hygiene;

16 (7) one representative from the Maryland Department of Human 17 Resources, appointed jointly by the County Commissioners of Cecil County and the 18 Secretary of Human Resources;

19 (8) one representative from the Maryland Department of Aging,
 20 appointed jointly by the County Commissioners of Cecil County and the Secretary of
 21 Aging;

(9) the President of the County Commissioners of Cecil County, or the
 President's designee;

(10) two individuals from the Cecil County Community Health Advisory
 Committee, appointed by the County Commissioners of Cecil County;

26 (11) one individual from a nonprofit community organization that 27 operates in Cecil County, appointed by the County Commissioners of Cecil County;

(12) one representative from the Children Youth & Family
 organization, appointed by the County Commissioners of Cecil County; and

(13) three individuals who are citizens of Cecil County, appointed by
 the County Commissioners of Cecil County.

5	(1) may not receive compensation as a member of the Task Force; but
$6 \\ 7$	(2) is entitled to reimbursement for expenses under the Standard State Travel Regulations, as provided in the State budget.

9 10 11	(1) study the benefits of merging the Cecil County Health Department, Social Services Department, and Senior Services & Community Transit Department, including:
12	(i) the impact on services provided;
13	(ii) potential organizational structures;
14	(iii) employee and staffing needs;
15	(iv) impact on State agency partnerships; and
16	(v) impact on State and Cecil County funding; and
17 18 19	(2) make specific recommendations to the County Commissioners of Cecil County on whether to merge the Cecil County Health Department, Social Services Department, and Senior Services & Community Transit Department.
$\begin{array}{c} 20\\ 21 \end{array}$	(g) (1) On or before January 15, 2010, the Task Force shall prepare an initial report of its findings and recommendations.
22 23 24	(2) On or before July 1, 2010, the Task Force shall prepare its final report of its findings and recommendations to the County Commissioners of Cecil County.
25 26 27 28	(3) Copies of the report submitted under paragraph (2) of this subsection shall be sent to the Maryland Department of Health and Mental Hygiene, the Maryland Department of Human Resources, and the Maryland Department of Aging.
29 30 31 32	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2009. It shall remain effective for a period of 1 year and 1 day and, at the end of July 1, 2010, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
