# 2 City of Annapolis - Alcoholic Beverages - Administrative Proceedings and 3 Fines

FOR the purpose of adding the City of Annapolis to the list of jurisdictions in which
the granting of probation before judgment to an alcoholic beverages licensee for
selling or furnishing alcoholic beverages to an underaged individual does not
bar the Board of License Commissioners from proceeding administratively
against the licensee for the violation; altering a certain fine that the City of
Annapolis may impose for a certain alcoholic beverages violation; and generally
relating to alcoholic beverages in the City of Annapolis.

(c) (2) In the City of Annapolis, the Board of License Commissioners may
 impose a fine of not more than [\$1,000] \$2,000 in lieu of suspension of a license for
 any violation that is cause for suspension under the alcoholic beverage laws of the city.

 October 1, 2009.
