A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Montgomery County**
3 **– Warren Historical Site – Loving Charity Hall**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007
5 to remove the Board of Directors of the Historic Medley District, Inc. as a
6 grantee; extending the deadline by which a certain grantee may present
7 evidence to the Board of Public Works that a matching fund will be provided;
8 and generally relating to the Maryland Consolidated Capital Bond Loan of 2007
9 and the Warren Historical Site – Loving Charity Hall in Montgomery County.

10 BY repealing and reenacting, with amendments,
11 Chapter 488 of the Acts of the General Assembly of 2007
12 Section 1(3) Item ZA01 (AS)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
14 MARYLAND, That the Laws of Maryland read as follows:

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
17 MARYLAND, That:

18 (3) ZA01 LOCAL HOUSE INITIATIVES

19 (AS) Warren Historical Site – Loving Charity Hall. Provide a grant
20 equal to the lesser of (i) \$175,000 or (ii) the amount of the
21 matching fund provided, [to the Board of Directors of the
22 Historic Medley District, Inc. and] to the Board of Directors of
23 the Warren Historic Site Committee, Inc. for the
24 reconstruction, repair, renovation, construction, and capital

1 equipping of Loving Charity Hall, located in Martinsburg,
 2 subject to a requirement that the grantee grant and convey a
 3 historic easement to the Maryland Historical Trust.
 4 Notwithstanding Section 1(5) of this Act, the matching fund
 5 may consist of real property, in kind contributions, or funds
 6 expended prior to the effective date of this Act.
 7 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**
 8 **GRANTEE HAS UNTIL JUNE 1, 2011, TO PRESENT**
 9 **EVIDENCE THAT A MATCHING FUND WILL BE PROVIDED**
 10 (Montgomery County) 175,000

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 12 June 1, 2009.
