## 2 Environment – Permit Applications – Notice Requirements

FOR the purpose of requiring notification by mail to certain record residential 3 <del>property owners</del> the Department of the Environment to electronically post on 4 the Department's website certain notice of certain permit applications under 5 6 certain circumstances and provide a method for certain persons to electronically 7 request certain information; requiring the notice to contain certain information; 8 requiring permit applicants to pay the cost of the notice; authorizing the 9 Department of the Environment to require the permit applicant to publish and send the notice; and generally relating to notice requirements for permit 10 applications. 11

8 [(b)] (C) The Department may REQUIRE THE APPLICANT TO publish AND
9 SEND the [notice or require the applicant to publish the notice] NOTICES REQUIRED
10 IN SUBSECTIONS (A) AND (B) OF THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 October 1, 2009.
