## A BILL ENTITLED

1 AN ACT concerning

2 **State Tobacco Authority – Repeal**

3 FOR the purpose of abolishing the State Tobacco Authority; specifying that the  
4 publisher of the Annotated Code of Maryland, in consultation with the  
5 Department of Legislative Services, shall correct certain cross-references and  
6 terminology rendered incorrect by this Act; and generally relating to the  
7 abolition of the State Tobacco Authority.

8 BY repealing

10 Section 7–101 through 7–419 and the title “Title 7. Tobacco”

11 Annotated Code of Maryland

12 (2007 Replacement Volume and 2008 Supplement)

13 BY repealing and reenacting, with amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
19 MARYLAND, That Section(s) 7–101 through 7–419 and the title “Title 7. Tobacco” of  
20 Article – Agriculture of the Annotated Code of Maryland be repealed.

21 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
22 read as follows:

17 [(14) (13) The Aquaculture Review Board; and

18 [(15) (14) The Aquaculture Coordinating Council.

19 SECTION 3. AND BE IT FURTHER ENACTED, That any balance remaining  
20 in the Tobacco Authority Fund after the effective date of this Act shall revert to the  
21 General Fund.

22 SECTION 4. AND BE IT FURTHER ENACTED, That the publisher of the  
23 Annotated Code of Maryland, in consultation with and subject to the approval of the  
24 Department of Legislative Services, shall correct, with no further action required by  
25 the General Assembly, cross-references and terminology rendered incorrect by this  
26 Act or by any other Act of the General Assembly of 2009 that affects provisions  
27 enacted by this Act. The publisher shall adequately describe any such correction in an  
28 editor's note following the section affected.

1           SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect  
2   October 1, 2009.
