16 17	Because of another's race, color, religious beliefs, sexual orientation, or national origin, <b>OR BECAUSE ANOTHER IS HOMELESS,</b> a person may not:

5 6 7	(1) because a person or group of a particular race, color, religious belief, sexual orientation, or national origin, <b>OR BECAUSE A PERSON OR GROUP THAT IS HOMELESS</b> , has contacts or is associated with the building; or
8 9 10	(2) if there is evidence that exhibits animosity against a person or group, because of the race, color, religious beliefs, sexual orientation, or national origin of that person or group <b>OR BECAUSE THAT PERSON OR GROUP IS HOMELESS</b> .
