- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:
- 15 Article Tax Property
- 16 9–305.
- 17 (b) The governing body of Baltimore County may grant, by law, a property
- 18 tax credit under this section against the county property tax imposed on:
- 19 (1) real property that is owned by the Twin River Protective and
- 20 Improvement Association, Incorporated;
- 21 (2) real property that is owned by the Bowley's Quarters Improvement
- 22 Association, Incorporated;

- 1 (3)real property that is owned by the Oliver Beach Improvement $\mathbf{2}$ Association, Incorporated; 3 real property that is owned by the Baltimore County Game and (4) 4 Fish Association; real property that is owned by the Eastfield Civic Association, 5 (5)6 Incorporated; 7 (6) real property that is owned by the Rockaway Beach Improvement 8 Association; 9 (7)real property that is used only for and occupied by the Fire Museum of Maryland: 10 real property that is owned by the Carney Rod and Gun Club; 11 (8)12 (9)real property improvements that promote business redevelopment, for which credit: 13 14 (i) the governing body shall define by law what improvements are eligible; and 15 16 (ii) on reassessment by the supervisor, the governing body shall 17 determine the credit as a percentage of the actual cost of the improvements: 18 each unit of a condominium (as both are defined in § 11–101 of the 19 Real Property Article), if: 20 the governing body of the county consults with the council of 21 unit owners (as defined in § 11–101 of the Real Property Article) of the condominium; 22and 23 the council of unit owners provides services or maintains common elements (as defined in § 11-101 of the Real Property Article) that would 2425 otherwise be the responsibility of the county: 26 dwellings, the land on which the dwelling is located and other improvements to the land if: 27 the dwelling is in a homeowners' association where the 28 29 dwelling has a declaration of covenants or restrictive covenants that may be enforced 30 by an association of members;

5 6	(i) owned by the Rosa Ponselle Charitable Foundation, Incorporated, known as "Villa Pace"; and
7	(ii) not exempt under this article;
8 9	(13) agricultural land, not including any improvements, that is located in an agricultural preservation district;
10	(14) real property that is owned by Friends of the Oliver House, Inc.;
11 12	(15) real property that is owned by the Bird River Beach Community Association, Inc.;
13 14	(16) real property that is owned by Harewood Park Community League, Inc.;
15 16	(17) real property that is owned by any other nonprofit community association, civic league or organization, or recreational or athletic organization;
17 18	(18) personal property that is owned by the Genesee Valley Outdoor Learning Center, Inc.;
19 20	(19) real property that is owned by The Maryland State Game and Fish Protective Association, Inc.; [and]
21 22	(20) personal property that is owned by Leadership Through Athletics, Inc.; AND
23 24	(21) REAL PROPERTY THAT IS OWNED BY CIVIC LEAGUE OF INVERNESS, INC.
25 26 27	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2009, and shall be applicable to all taxable years beginning after June 30, 2009.
