FOR the purpose of authorizing the governing body of Baltimore County to grant, by law, a property tax credit against the county property tax imposed on real property that is owned by Civic League of Inverness, Inc.; providing for the application of this Act; and generally relating to property tax credits in Baltimore County for Civic League of Inverness, Inc. BY repealing and reenacting, with amendments, Article – Tax – Property Section 9–305(b) Annotated Code of Maryland (2007 Replacement Volume and 2008 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Tax - Property 9 - 305.The governing body of Baltimore County may grant, by law, a property tax credit under this section against the county property tax imposed on: real property that is owned by the Twin River Protective and Improvement Association, Incorporated;
