2 **Natural Resources – Tree Services – Advertising**

3 FOR the purpose of prohibiting a person from advertising certain tree services unless
4 certain information is included in the advertisement; and generally relating to
5 advertising and tree services.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – Natural Resources**

14 5–423.

15 (a) A person may not: (1) solicit, advertise, or represent the person to the
16 public as a tree expert, or assume to practice as a tree expert without having received
17 a license; or (2) after having received the license and subsequently losing it by
18 revocation or suspension continue to practice as a tree expert, or; (3) use the title or
19 abbreviation “L.T.E.” or any other words, letters, or abbreviations tending to indicate
20 that the person is a licensed tree expert or a tree expert without having received a
21 license, or when the license has been revoked or suspended.

1 (b) If the owner of a tree employs any person to engage in the practice of a
2 “licensed tree expert” as provided in § 5–415, the owner is not subject to this penalty.

3 (c) **A PERSON MAY NOT ADVERTISE THAT THE PERSON CAN PROVIDE**
4 **TREE SERVICES, INCLUDING TREATMENT, CARE, OR REMOVAL OF TREES,**
5 **UNLESS THE ADVERTISEMENT INCLUDES:**

6 (1) **THE LICENSE NUMBER OF THE LICENSED TREE EXPERT**
7 **ADVERTISING TREE SERVICES IN ONE OF THE FOLLOWING FORMS: “LICENSED**
8 **TREE EXPERT NO.____” OR “L.T.E. NO.____”; OR**

9 (2) **A STATEMENT THAT ALL TREE SERVICES ARE LIMITED TO**
10 **TREES 20 FEET TALL OR LESS.**

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 October 1, 2009.
