Vehicle Laws - Drivers' Licenses, Identification Cards, and Moped Operators' Permits - Proof of Lawful Presence

FOR the purpose of requiring the Motor Vehicle Administration to issue an identification card or moped operator's permit to an individual who, in addition to meeting certain other requirements, provides certain documentation certifying that an individual is either a United States citizen or is lawfully present in the United States in accordance with federal law; prohibiting the Administration from issuing a driver's license to an individual who cannot provide certain documentation certifying that the individual is either a United States citizen or is lawfully present in the United States in accordance with federal law; requiring an application for a driver's license to include certain documentation; providing that the effective term of an identification card, driver's license, or moped operator's permit issued to a certain individual may not exceed the time that the individual is authorized to remain in the United States in accordance with federal law; altering a certain provision that requires a driver's license application to include a Social Security number to apply only to an applicant who is eligible for a Social Security number; requiring an applicant for a driver's license who is not eligible for a Social Security number to provide certain documentation to the Administration; making certain technical corrections; and generally relating to individuals who are not lawfully present in the United States and the issuance of identification cards, drivers' licenses, and moped operators' permits.
