11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 12 MARYLAND, That the Laws of Maryland read as follows:

Article – Natural Resources

(a) The General Assembly finds that it is in the public interest to provide
funding to reimburse a person who has sustained damage to agricultural products as a
result of black bear.

- 18 (b) (1) There is a Black Bear Damage Reimbursement Fund in the19 Department.
- 20 (2) The Fund consists of:
- (i) Proceeds from the sale of a conservation bear stamp or decal
 which may be purchased at a cost of \$5 for each stamp or decal; and

$\frac{3}{4}$	(3) The Fund is a continuing, nonlapsing special fund, and is not subject to § 7–302 of the State Finance and Procurement Article.
5 6	(4) The State Treasurer shall hold and the State Comptroller shall account for the Fund.
7 8 9	(c) The Department may reimburse a person from the Black Bear Damage Reimbursement Fund in accordance with subsections (d) and (e) of this section for any damage to the person's:
10	(1) Beehives, fruit, or other crops; or

13	(d) (1) A person is eligible to be reimbursed from the Fund if:
14 15	(i) The person has followed all black bear damage preventive measures recommended by the Department;
16 17	(ii) The damage amount is determined by an extension agent of the University of Maryland Cooperative Extension Service; and
18 19	(iii) The Department has verified that the damage was caused by black bear.
20 21	(2) Subject to available funding, a person may be reimbursed from the Fund in an amount not less than \$200 or more than \$3,000 per year.
22 23 24 25 26 27	(e) If the money in the Fund is not sufficient to satisfy all the claims in accordance with the conditions described in subsection (d) of this section, [an equal percent of each claim shall be paid] PERMIT APPLICATION FEES COLLECTED BY THE DEPARTMENT FOR THE BLACK BEAR HUNTING PERMIT LOTTERY SHALL BE USED TO MAKE UP THE DIFFERENCE BETWEEN THE FUND BALANCE AND THE AMOUNT SUFFICIENT TO SATISFY ALL THE CLAIMS.
