3 FOR the purpose of requiring the Department of State Police to establish a Silver 4 Alert Program to disseminate information to assist in locating certain missing 5 persons who suffer certain impairments; requiring the Department to adopt 6 guidelines and develop procedures for issuing a Silver Alert for a certain 7 missing person; requiring the Department to provide training to local law 8 enforcement agencies on the guidelines and procedures to be used to handle a 9 report of a certain missing person; requiring the Department to provide assistance to a local law enforcement agency as necessary to assist in the safe 10 recovery of certain missing persons; requiring the Department to recruit certain 11 persons to assist in developing and implementing the Silver Alert Program; 12 requiring the Department to consult with the State Highway Administration to 13 14 establish a certain plan for providing information to the public; requiring the Department to consult with the State Board of Education to develop a program 15 to allow high school students to assist in the search for a missing person and 16 17 receive student service credit; requiring a certain person to notify a certain local law enforcement agency and the Department regarding certain information 18 19 under certain circumstances; defining certain terms; and generally relating to the establishment of a Silver Alert Program. 20
