4 (e) A conviction under this section shall disqualify the defendant from 5 inheriting, taking, enjoying, receiving, or otherwise benefiting from the estate, 6 insurance proceeds, or property of the [vulnerable adult] VICTIM OF THE OFFENSE, 7 whether by operation of law or pursuant to a legal document executed or entered into 8 by the [vulnerable adult] VICTIM before the defendant shall have been convicted 9 under this section and shall have made full restoration of the property taken or of its 10 value to the [vulnerable adult] VICTIM.

11 (f) This section may not be construed to impose criminal liability on a person 12 who, at the request of the [vulnerable adult] **VICTIM OF THE OFFENSE**, the 13 [vulnerable adult's] **VICTIM'S** family, or the court appointed guardian of the 14 [vulnerable adult] **VICTIM**, has made a good faith effort to assist the [vulnerable 15 adult] **VICTIM** in the management of or transfer of the [vulnerable adult's] **VICTIM'S** 16 property.
