## A BILL ENTITLED

1 AN ACT concerning

2 **Allegany County – Video Lottery Construction – Local Impact Grants – Rocky**  
3 **Gap Construction Costs**

4 FOR the purpose of authorizing local impact grants from proceeds of certain video  
5 lottery terminals to be used in Allegany County for certain purposes and to pay  
6 down certain debt incurred by the county in the construction and related costs  
7 for the golf course, lodge, and other improvements in Rocky Gap State Park; and  
8 generally relating to video lottery gaming and local impact grants from gaming  
9 proceeds in Allegany County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – State Government**

23 9–1A–02.

24 (b) (1) The Commission shall regulate the operation of video lottery  
25 terminals in accordance with this subtitle.

2 (b) (1) [Local] **EXCEPT AS OTHERWISE PROVIDED IN PARAGRAPH (2)**  
3 **OF THIS SUBSECTION, LOCAL** impact grants provided under subsection (a)(1)(i) of  
4 this section shall be used for improvements in the communities in immediate  
5 proximity to the video lottery facilities and may be used for the following purposes:

6 [(1)] (I) infrastructure improvements;

7 [(2)] (II) facilities;

8 [(3)] (III) public safety;

9 [(4)] (IV) sanitation;

10 [(5)] (V) economic and community development, including housing;

11 and

12 [(6)] (VI) other public services and improvements.

13 (2) **IN ALLEGANY COUNTY, LOCAL IMPACT GRANTS PROVIDED**  
14 **UNDER SUBSECTION (A)(1)(I) OF THIS SECTION MAY BE USED:**

15 (I) **FOR PURPOSES LISTED IN PARAGRAPH (1) OF THIS**  
16 **SUBSECTION THROUGHOUT THE COUNTY; AND**

17 (II) **TO PAY DOWN THE DEBT INCURRED BY THE COUNTY IN**  
18 **THE CONSTRUCTION AND RELATED COSTS FOR THE GOLF COURSE, LODGE, AND**  
19 **OTHER IMPROVEMENTS IN ROCKY GAP STATE PARK.**

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
21 October 1, 2009.
