BY repealing and reenacting, with amendments, Article – Labor and Employment Section 9-233 and 9-602(j)Annotated Code of Maryland (2008 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - Labor and Employment** 9-233.Each volunteer deputy sheriff of Cecil County is a covered employee while performing work assigned by the sheriff of the county.
