1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 2B – Alcoholic Beverages**

5 (b) (2) The fee for such license shall be one hundred dollars (\$100) each
6 calendar year, and shall entitle the holder to sell beer at one or more locations within
7 the park from 8 a.m. to [12 p.m.] **MIDNIGHT** on every day from May 1 to September
8 30 of each year, except Sundays and election days.
